Lesson 8

- 1. Last week I completed an analysis of the Doctrine of Manna and how it related to the first Sabbath: a seventh day to commemorate that God had done all he could do for man. Now it was man's job to rest in God's Sabbath.
- 2. Ever since the seventh day of the restoration God has been offering mankind a rest, a Sabbath, and ever since that seventh day mankind has been resisting God's Sabbath rest.
- 2.1 Let's review the *Doctrine of Faith Rest*.
- 1. The Fear Panic Ploy
- 1.1 It is possible to spend much time in the Word of God and fall apart in an emergency or time of great pressure and personal testing.
- 1.1.1 Recognize this as fact.
- 1.2 Sudden disaster can bring a believer to a point where he cannot concentrate on doctrine, nor perceive that God is in charge.
- 1.3 It is therefore important for us to know that the difference between fear and courage is our ability to concentrate objectively while under pressure.
- 1.3.1 This means we must be able to recall previously learned doctrine.
- 1.4 The coward cannot think under pressure, while the man of courage can summon his senses and think of the solution rather than the problem.
- 1.5 Concentration is required to learn and apply doctrine under pressure.
- 1.5.1 Fear destroys the ability to concentrate.
- 1.6 Adversity, suffering and disaster all destroy concentration, both in learning and applying doctrine.
- 1.7 The suddenness or intensity of disaster causes panic and hinders the ability to concentrate and apply doctrine.
- 1.8 The normal reaction to disaster is fear and with fear comes panic, however, it is abnormal for the mature believer when fear is permitted to continue.

1.9 Since fear is so prevalent, universal, detrimental and a mental attitude sin, the Bible has many imperatives relating thereto.

Deu 31:6 Be strong and courageous. Do not be afraid or terrified because of them, for the LORD your God goes with you; he will never leave you nor forsake you."

Deu 31:7 Then Moses summoned Joshua and said to him in the presence of all Israel, "Be strong and courageous, for you must go with this people into the land that the LORD swore to their forefathers to give them, and you must divide it among them as their inheritance.

Deu 31:8 The LORD himself goes before you and will be with you; he will never leave you nor forsake you. Do not be afraid; do not be discouraged."

Isa 41:10 So do not fear, for I am with you; do not be dismayed, for I am your God. I will strengthen you and help you; I will uphold you with my righteous right hand.

Isa 41:11 "All who rage against you will surely be ashamed and disgraced; those who oppose you will be as nothing and perish.

Isa 41:12 Though you search for your enemies, you will not find them. Those who wage war against you will be as nothing at all.

Isa 41:13 For I am the LORD, your God, who takes hold of your right hand and says to you, Do not fear; I will help you.

2Ti 1:7 For God hath not given us the spirit of fear; but of power, and of love, and of a sound mind.

- 2. The loss of prosperity, loss of loved one, loss of health, loss of work, experiencing critical illness, etc., can all produce fear.
- 2.1 Fear makes difficult the recall of Biblical promises.
- 3. The loss of things we deem valuable produces instant panic, and the mind must be stabilized before doctrine can be applied.
- 4. The solution to the fear problem is found in the use of the faith-rest technique, i.e., by recycling Biblical promises to abrogate fear.
- 5. David uses the Faith-Rest technique when he says he will slam his troubles on the Lord.

Psa 56:3 When I am afraid, I will trust (**Batach** means to slam trouble down or it also has the meaning of hiding in a cave) in you.

6. The fear of death is evil and the fear of death comes from the devil.

Psa 23:4 Yea, though I walk through the valley of the shadow of death, I will fear no evil: for thou art with me; thy rod and thy staff they comfort me.

Heb 2:14 Forasmuch then as the children are partakers of flesh and blood, he also himself likewise took part of the same; that through death he might destroy him that had the power of death, that is, the devil;

Heb 2:15 And deliver them who through fear of death were all their lifetime subject to bondage.

- 7. Fear and evil cover the land today, in the form of fears about a lack of energy, war, depression, revolution, destruction of the environment etc.
- 8. God has delivered us from fear and all forces which motivate fear.
- 8.1 Through the Faith-Rest drill you can and should have a relaxed mental attitude toward all these things.

Job 5:19 From six calamities he will rescue you; in seven no harm will befall you.

Job 5:20 In famine he will ransom you from death, and in battle from the stroke of the sword.

Job 5:21 You will be protected from the lash of the tongue, and need not fear when destruction comes.

Job 5:22 You will laugh at destruction and famine, and need not fear the beasts of the earth.

Job 5:23 For you will have a covenant with the stones of the field, and the wild animals will be at peace with you.

Job 5:24 You will know that your tent is secure; you will take stock of your property and find nothing missing.

Job 5:25 You will know that your children will be many, and your descendants like the grass of the earth.

Job 5:26 You will come to the grave in full vigor, like sheaves gathered in season.

Job 5:27 "We have examined this, and it is true. So hear it and apply it to yourself."

9. We should take in the Word so we can know about our security.

Rom 8:28 And we know that all things work together for good to them that love God, to them who are the called according to his purpose.

Rom 8:29 For whom he did foreknow, he also did predestinate to be conformed to the image of his Son, that he might be the firstborn among many brethren.

Rom 8:30 Moreover whom he did predestinate, them he also called: and whom he called, them he also justified: and whom he justified, them he also glorified.

Rom 8:31 What shall we then say to these things? If God be for us, who can be against us?

11. Each believer should get under the authority of his pastor-teacher, metabolize doctrine and cast all cares on God.

1Pe 5:2 Be shepherds of God's flock that is under your care, serving as overseers--not because you must, but because you are willing, as God wants you to be; not greedy for money, but eager to serve;

1Pe 5:3 not lording it over those entrusted to you, but being examples to the flock.

1Pe 5:4 And when the Chief Shepherd appears, you will receive the crown of glory that will never fade away.

1Pe 5:5 Young men, in the same way be submissive to those who are older. All of you clothe yourselves with humility toward one another, because, "God opposes the proud but gives grace to the humble."

1Pe 5:6 Humble yourselves, therefore, under God's mighty hand, that he may lift you up in due time.

1Pe 5:7 Cast all your anxiety on him because he cares for you.

12. When in trouble don't assume you know it all; because you certainly don't says the Lord.

13. Prayer, when properly applied, will facilitate recovery from anxiety.

Phi 4:7 And the peace of God, which transcends all understanding, will guard your hearts and your minds in Christ Jesus.

1Ti 2:1 I exhort therefore, that, first of all, supplications, prayers, intercessions, and giving of thanks, be made for all men;

17. How we handle a normal day is how we handle an abnormal day, i.e., are we going to think human or divine viewpoint.

Is a 26:3 Thou wilt keep him in perfect peace, whose mind is stayed on thee: because he trusteth in thee.

- 18. A major Faith-Rest principle is eternal security.
- 19. You cannot Faith-Rest if you doubt the efficacy of Christ's work.
- 20. To use the Faith-Rest drill you must be confident in your position in Christ.
- 21. If we worry over sin in time we become casualties in the angelic conflict.

21.1 Sin is no longer an issue, all sin was nailed to the cross; when we cite a sin to God it is forgotten; we are forgiven and purified.

1Jo 1:8 If we say that we have no sin, we deceive ourselves, and the truth is not in us.

1Jo 1:9 If we confess our sins, he is faithful and just to forgive us our sins, and to cleanse us from all unrighteousness.

1Jo 1:10 If we say that we have not sinned, we make him a liar, and his word is not in us.

1Jo 2:1 My little children, these things write I unto you, that ye sin not. And if any man sin, we have an advocate with the Father, Jesus Christ the righteous:

23.1 Claim a promise to stabilize the mind - God works all things together for the good.

23.2 Use reverse process concentration:

- Foreknowledge: God thought about me in eternity past.
- Predestination: God had a plan for me in eternity past.
- Election: God saw my choices and chose me.
- Justification: God can now bless me because He is propitiated.
- Glorification: God is exalted when I am blessed.

23.3 Reach doctrinal conclusions:

- If God is for me who can be against me?
- God saved me when I was His enemy; how shall He not now provide for me now that I am family?
- 24. Conclusion-When you are caught up in some dreadful disaster; remember that no matter how grave the danger, as a mature believer, you are perfectly safe in the Lord's hands. Let's return to our study of Lesson Eight.
- 3. We spent some time noting how the grandeur of creation is sufficient for man to recognize the essence and nature of God.
- 4. Even after observing the grandeur of the Garden, mankind chose to fall. This fall resulted in man being forced from the Garden and thus ended the age of innocence.
- 5. After the fall Adam and Eve by copulation produced Cain and Abel, Cain an unbeliever slew Abel leaving earth without a believing heir.

- 6. Later, however, a new believer was born to Adam and Eve along with many daughters. The new believer was named Seth.
- 7. The earth's population then grew by leaps and bounds, the Bible taking note of such men as Enosh, Kenan, Mahalalel, Jared, Enoch, Methuselah, Lamech and Noah.
- 8. Now I want to fast forward to the flood but first we need an introduction.
- 9. Given the fact the Bible "claims" a great flood occurred sometime between 3500 and 5000 B.C., many skeptics have expressed doubt that any such phenomena ever took place. This you might expect in the devil's world.
- 10. There are numerous scientific studies which both refute and support the flood. We need no convincing given our belief in the infallible Word of God but since secular view point seems to get all the press, let's look at a couple of articles which raise certain interesting questions.

Alley-Oop!--by Probe Ministries, 1973

"Recall that according to evolutionary thought, the dinosaur walked the earth two hundred million years ago and became extinct during the Cretacious period seventy million years ago. The soil on which he walked would have become solid rock 70,000,000 years before the appearance of man, in the evolutionary view of time. But well-established human tracks exist side-by-side with those of the Tyrannosaurus and Brontosaurus in the Paluxy riverbed near Glen Rose, Texas.

"The rock is a Cretaceous formation, dating roughly one hundred million years old. It has been suggested that these human footprints are carvings. Indians are known to have carved footprints, and perhaps they did these, some say. However, footprints carved by the Indians resemble the real prints of a moving man like Kawliga the Wooden Indian resembles a modern American Indian. Carved footprints are copies of the bottom of a foot, but bear none of the markings that accompany the motion and pressure of real walking feet. Well, you may say, if it were true that dinosaur and human footprints exist side-by-side in the rock formation of a single age, it would have been published by now, and I would have read it in a book or magazine article. It has been published, filmed, described and verified in books, symposiums and journals. It's just that none of them have been assigned to you. Dr. A. E. Wilder Smith, a gentleman with three earned doctorates in the physical sciences, has been among many to visit the Paluxy river-bed and pronounce the tracks genuine. Furthermore, chemical analysis confirms this same conclusion to the closer observer. Now perhaps you are smiling, because the idea of contemporaneous dinosaur and human prints does turn on its own entertaining little glow in one's mind. But you'll still go for the carved-print theory. To you, I've just said two and two aren't four. Okay, but do read on. A geologist named Meister was snooping around in a Cambrian formation near Antelope Springs, Utah, in June of 1968. He hit a piece of rock with his hammer, and it fell open like the pages of a book.

"There, staring him in the face was a size 9 human sandal-print. Crushed in the heel and toe of this now fossilized sandal-print were several trilobites. The trilobite is the index fossil of the Cambrian period (the period of time when the evolutionists suppose that life first sprang forth into a variety of primitive forms.) Now the trilobite became extinct late in the Permian period (two hundred million years ago) and "uncrushable" a few years later. So Mr. Meister felt he might have a significant find on his hands, since sandals were not invented until the coming of man more than 200,000,000 years after the Permian period when the trilobite became extinct. Here are two creatures then, trilobite and man, held by evolutionary thought to have been separated by millions of years of time. What this find does is indicate that they actually lived at one and the same time or something, maybe weird rock layer juxtapositions occurred because ...?

"In the mid-sixties, a research team from the Geochronology Department of the University of Arizona, under the direction of world-famous paleontologist Gerhardt Kremp, picked their way to the base of the Grand Canyon and took a number of rock samples from a Precambrian rock formation called Hakati Shale. This strata is said by evolutionists, geologists, stratigraphers to have been formed over five hundred million years ago. That's two hundred and fifty million years before the evolution of the pine tree (conifer). The team brought back the rock samples, which were prepared in laboratories for viewing of their microscopic content by Dr. Clifford Burdick, another paleontologist. Under the microscope, they proved to be riddled throughout with the fossilized spores of pine tree pollen! Pine tree pollen in rocks hardened two hundred and fifty million years before the coming of the pine tree. Imagine the child living two hundred and fifty million years before its parent!

"Well, the find, need I say, was pretty controversial. It was decided that the pollen spores were contaminants. That is, to say they had entered the rock samples at the time the samples were taken. But another team of scientists looked at them and their conclusion was that since the mineral content of the spores was the same as that of the rock in which they were found, they were actually fossilized right where they were now viewed and were not contaminants!

"But the Grand Canyon isn't that far. So in the summer of 1970, another team dispatched by Loma Linda University trekked to the base of the Canyon for more samples. Later, it was my privilege to share this topic in an LSU geology class, with a member of this second team sitting-in. The class heard a detailed description of the extreme precautions taken by the second team to preclude any possibility of bringing back contaminated samples. (Only rock recessed two feet, rubber gloves, rapid packaging and marking, and sterilized bags.) Then the class viewed a slide of a fossilized pine tree pollen spore ... from samples taken on the second expedition. Keep in mind that nobody can carve a microscopic pollen spore. The conclusion strongly suggested is that the time which evolutionists say elapsed between the Precambrian period and the Pennsylvanian period never occurred. These three evidences are exemplary of hundreds that tell us rock strata must be better understood in some other framework. In the face of these provoking facts, creationism offers a powerful and satisfying alternative ..."

How Long Can You Tread Water - by Probe Ministries, 1973

"The September 1969 issue of Scientific American is devoted to a study of the ocean. In his article, "Continental Shelves," K.O. Emory discusses a change in level of the world's oceans, stating ... "it rose rather rapidly to within about five meters of the present level 5,000 years ago." According to Emory, this is a rise of 130 meters. The date he cites is highly significant since it is in the ballpark of the Biblical date of the flood, (3500-5000 B.C.) The canopy would indeed provide the rain, but what about a mechanism for the canopy's collapse? How can we explain its suspension in the earth's atmosphere for a thousand years or more, and then its sudden disintegration? Genesis 6 tells us God did it, and why. The question is, did He use natural means, or supernatural? ... it certainly is legitimate to look around for possible natural causes at this point.

"Several have been suggested, but we'll consider one--the possibility that volcanic activity was the mechanism that caused the canopy to collapse. Volcanic eruptions could put millions of particles of dust and volcanic ash into the earth's atmosphere, providing the condensation nuclei around which the water vapor of the canopy could then be precipitated and fall as rain. To illustrate the vast potential in a period of intensive volcanic activity, consider the enormity of a single eruption, that of Krakatoa in the East Indies. In 1883 Krakatoa blew her top and put four cubic miles of solid material into the earth's atmosphere. The volcanic dust thus suspended was enough to darken the sunsets and sunrises, and lower the average temperature of the earth for over a year!

"As the canopy collapsed, atmospheric pressure would drop rapidly, just as when air escapes from a tire. The gas laws tell us that the expansion of any gas, including the earth's atmosphere, is accompanied by a corresponding drop in temperature. This drop in temperature would be radical and varied from location to location. High velocity wind would augment these already cascading drops in temperature. Precipitation in the polar regions would thus be in the form of huge ice dumps rather than rain. At this point, let's turn to some investigations of polar ice, to see if we can find confirming evidence of volcanic activity coinciding with the buildup of the ice. An Army Col. and the regions geologist, Anthony Gow, has taken 7,100 feet of core samples from nine Antarctic glaciers. (A core sample is like dipping into the glacier with a big cookie-cutter and drawing out a deep cross section to look at.) He found over 2,000 individual samples of volcanic ash inter bedded within the ice. Here is evidence that the ice we now have at the poles has not thawed since the collapse of the canopy, and has thus preserved the volcanic material within it. Before we leave the subject of cold weather, I'd like to make lateral reference to some information coming from a sister science, anthropology.

"Canadian anthropologist Arthur Custance, author of the Doorway Papers, has written one entitled Flood Traditions of the World, in which he points out the overwhelming number of references, accounts, mythologies, folklores and histories of a world-wide flood. These accounts come from both primitive and highly civilized peoples all over the globe. On pages 23-25 he lists 130 of these stories and also states that a frequent feature of many of them is the mention of the great chilling and cold of the flood survivors.

And we would expect the memory of harsh new conditions to be firmly implanted into the minds of the flood survivors and their offspring."

So thus far we have:

- the earth created with a water vapor canopy
- physical conditions altered by the canopy's existence
- the collapse of the canopy at the time of Noah's flood
- logical orderly rock formations are not always found

The Canopy--By Probe Ministries, 1973

"Genesis 1:6-7 (RSV) says, "God said, Let there be a firmament in the midst of the waters, and let it separate the waters from the waters. And God made the firmament and separated the waters which were under the firmament from the waters which were above the firmament. And it was so." I take this to refer to a clear canopy of water vapor which enveloped planet earth from the time of the creation referred to here, until the flood of Noah's day at which time this canopy collapsed providing the 40 days and 40 nights of rain.

"During its existence the canopy caused what meteorologist call an entirely different atmospheric regime, i.e., it dictated the weather phenomena and conditions of the atmosphere. Depending on the volume of water in the canopy, it would cause an atmospheric pressure several times that of our present day. It is interesting that several experiments have studied life under such pressure and found it to be more beneficial than our present pressure with significant health benefits.

"A second effect of the canopy would be a "greenhouse effect" providing an equalizing of temperatures from Pole to Pole. Now if such an equalization existed we should expect to find fossil evidence that climatic conditions were much warmer at one time than at the present time. This would provide large tropical and sub-tropical plant and animal life in locations now too cold to support such flora and life forms. That is exactly what we have found. On mountain peaks at the South Pole Admiral Byrd found the fossils of a lush tropical forest. In the New Siberian Islands, a 90 foot fruit tree was discovered buried in the frozen tundra, with luscious foliage and fruit still intact. The largest trees indigenous to this frosty area are now one inch willows! And across the Arctic Circle, Greenland, Siberia, and Northern Canada we find fossil evidence of large animals and a tropical plant life that would be enough to make any horticulturist drool.

"A third condition of this pre-flood atmospheric regime is a significant reduction in radiation due to the filtering effects of the canopy. The water would screen out much of the high energy radiation, cosmic, ultraviolet, gamma etc. which now penetrates to the earth's surface. Doubtless you know there are many deleterious effects of too much radiation.

"Extreme exposure can kill and there are a variety of negatives which can reduce life expectancies. Radiation is capable of generating cancer and causing an endless array of gene mutations, and these are almost always harmful. It has been long conjectured by many reputable scientist that a canopy would cause life expectancies to drastically extend. This is what we find recorded in the Bible. After the Flood we find life expectancies gradually being reduced to what we today call three score and ten. Before the Flood we had ages recorded of 900 plus years. Not only does the Bible record these extended pre-flood life spans but so also does folklore, epics and mythologies of many ancient cultures. Why? Many have surmised that people have always admired growing old and then there are others with a more scientific view who believe the canopy caused this phenomena."

- 11. It is clear from the article entitled The Canopy that the water surrounding the atmosphere of planet earth would certainly have created special and unique phenomena not presently observed.
- 11.1 I want to close our little excursion with one last anecdote which might be titled "Birth of An Island." Charles Hunt, then President of the American Geological Institute cites this anecdote as one of many reasons why carbon dating leaves much to be desired.

"An island in the near Pacific (this little island was Kilauea) with a known short lived life was dated by Carbon 14 and said to be between 0 to 22 millions years. Experts when queried about the "scientific slop " responded: "Because the island was underwater so long before it rose cataclysmically from the ocean, there was a shielding by the water of cosmic radiation, therefore less Carbon 14 build-up due to very few cosmic rays bombarding nitrogen atoms."

- 11.2 Little did these experts realize at the time this very accurate statement explains the great disparities of Carbon 14 datings when antediluvian versus post-diluvian dates are compared. In Gen 1: 7 God said He placed a canopy of water around the atmosphere or firmament covering planet earth.
- 11.3 At the time of the great flood which is estimated to be about 4000 B.C. (based on a number of "good scientific" as well as Biblical reasons) the canopy of water collapsed and we had one heck of a rain.
- 11.4 This was the first time planet earth saw rain. The canopy made for a deluge and ended the great shielding which had formerly kept Carbon 14 from building up at "normal" post-diluvian rates.

End Lesson
